STATEMENT ON BEHALF OF [REDACTED]
FOR CLAIMS AGAINST THE ARCHDIOCESE OF BOSTON

Mr. [REDACTED] was born on [REDACTED] and currently resides in [REDACTED] Massachusetts. Mr. [REDACTED] was repeatedly sexually molested by Fathers Barrett, Dwyer and Dunn. The abuse occurred when the three priests were assigned to St. Mary's in Hull, Massachusetts between the years of 1967 and 1968 when Mr. [REDACTED] was 12 to 13 years old. Mr. [REDACTED] lived 100 yards away from the rectory and delivered the newspaper daily.

Father Dwyer was the pastor of St. Mary's and when Mr. [REDACTED] would visit the rectory Father Dwyer would place him on his lap. Father Dwyer would make him rub his beard and would bear hug Mr. [REDACTED]. While hugging Mr. [REDACTED] he would grope Mr. [REDACTED] genitals inside his pants. Father Dunn had asked Mr. [REDACTED] to answer the rectory phone in the evenings. Father Dunn would wrestle with Mr. [REDACTED] and would hump Mr. [REDACTED] from behind. There were times when this occurred after Father Dunn had taken Mr. [REDACTED] pants off.

Both Fathers Dunn and Dwyer would often abuse Mr. [REDACTED] together. Father Dunn would Mr. [REDACTED] down while Father Dwyer would pull Mr. [REDACTED] pants off and grope him. On one occasion, Mr. [REDACTED] was saved by the housekeeper, Mrs. Haley, walking him.

Mr. [REDACTED] was also abused by Father Barrett who was a curate at St. Mary's. Father Barrett was new and asked Mr. [REDACTED] to train as a lector. This started in approximately November, 1967 and the training would take place at night. Mr. [REDACTED] remembers Father Barrett having a new car either a 1968 Camaro or Mustang which was bronze in color. During the training, Father Barrett introduced

Mr. [REDACTED] to a 17 year old boy by the name of [REDACTED] Mr. [REDACTED] would tell Mr. [REDACTED] that he should do whatever Father Barrett asked. In May or June, 1968, Father Barrett took Mr. [REDACTED] to Father Barrett's parents' house in Maine with Mr. [REDACTED]. The house was on a lake. On this trip, Father Barrett would set up the house as if there were to be a ritual. The house was full of candles but no electric lights. After Mr. [REDACTED] had gone to bed, Father Barrett tried to get into bed with him. Father Barrett grabbed Mr. [REDACTED] genitals at which point Mr. [REDACTED] ran out of the house and spent the night in a boat.
