Father DUFFY said that he would not make any comment at this time and was instructed by Father Chris's attorney.

After this statement it was obvious to me that Father DUFFY was not willing to answer any questions regarding this incident. He said as soon as he contacted that he would be happy to cooperate, however, at this time was obliged not to.

4-28-86 1520 Hours I explained the investigation and told him that it apparently took place three years ago this April. I told that I had earlier visited with Father DUFFY in order to obtain information about this situation. I explained that Father DUFFY was reluctant to talk until I contacted him and obtained permission.
