LAST WILL AND TESTAMENT

OF

RIGHT REVEREND JOSEPH V. CLARKIN

IN THE NAME OF GOD AMEN:

I, RIGHT REVEREND JOSEPH V. CLARKIN, a resident of the County of San Diego, State of California, being of sound and disposing mind and memory, and not acting under duress, fraud or the undue influence of any person whomsoever, do hereby make, publish and declare this my Last Will and Testament, and I do hereby expressly revoke all former Wills and Codicils to Wills by me made in the manner following, that is to say:

FIRST: I direct that all my personal bills, expenses of last illness, funeral expenses and luncheon for the Clergy be paid by my Executor. I direct that La Jolla Mortuary have charge of my funeral. I direct that my body be decently buried with proper regard to my station in life and the circumstances of my estate. I request that my funeral, rosary and Mass take place in Mary, Star of the Sea Church, La Jolla, where I was Pastor for thirty years. It is my express wish that there be no eulogy or homily at my funeral Mass, except for a short meditation on death by Father Thomas F. Byrne, if he is available and that one decade of the rosary be recited after the Mass in honor of Mary, Star of the Sea, for the happy eternal repose of my soul.

SECOND: I direct that the sum of NINE HUNDRED DOLLARS (\$900.00) be distributed to my Executor out of my estate

to be held in trust by him for redistribution to other priests of his choice for the purpose of having three hundred (300) Masses offered for the repose of my soul, and that an additional sum of THREE HUNDRED DOLLARS (\$300.00) be so distributed for the purpose of having one hundred (100) Masses offered for the repose of the souls of my deceased parents and family.

THIRD: I give and bequeath my clothing, personal effects and such household furniture as I may possess at the time of my death to FATHER THOMAS F. BYRNE or if he is then deceased, to FATHER MICHAEL J. COUGHLAN of St. Michael's Church, Poway, California, to be disposed of by said recipient as he may see fit.

FOURTH: I give the following cash bequests to the following persons:

s. To the SISTERS OF MERCY, Box 155, Kitui Post Office, Kenya, East Africa, the sum of TWO THOUSAND DOLLARS (\$2,000.00).

t. To FATHER THOMAS J. BYRNE, Our Lady of Mt. Carmel Church, San Ysidro, California, the sum of FIVE THOUSAND DOLLARS (\$5,000.00) to be used for the building of the proposed new church in said parish.

u. To the SISTERS OF NAZARETH, Nazareth House, San Diego, California, the sum of FIVE THOUSAND DOLLARS (\$5,000.00) to be used for their orphanage.

v. To MRS. REDACTED 12576 Lomica Drive, San Diego, California 92128, the sum of ONE THOUSAND DOLLARS (\$1,000.00).

w. To the SOCIETY FOR THE PROPAGATION OF THE FAITH the sum of TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00).

x. If any of the foregoing bequests are not disposed of to the persons or organizations named in each such subparagraph, either by reason of death or otherwise, then I direct that the sum of money bequeathed under said subparagraph shall be disposed of as part of the residue of the estate. I further direct that if there are insufficient funds to pay all of the foregoing bequests, then the gift in paragraph w. to the SOCIETY FOR THE PROPAGATION OF THE FAITH shall first lapse, and if there are still insufficient funds, then all of the remaining bequests shall be reduced proportionately.

FIFTH: All of the rest, residue and remainder of my estate to THE DIOCESE OF SAN DIEGO, a corporation sole, to reimburse the San Diego Diocesan Clergy Plan for what it has paid me during the time of my retirement and for what it has paid for my doctor's and hospital bills during my illness.

SIXTH: a. For the information and guidance of my Executor, I hereby state that at the date of my death, I may have

a bank account in the Central Bank of Ireland, College Green, Dublin, Ireland. In addition, I may have Irish Government Loan stock in the Central Bank of Ireland, College Green, Dublin, Ireland, and I direct that such asset be sold and the proceeds divided as follows: SEVENTY-FIVE PERCENT (75%) thereof to be given to the KILTEEGAN FATHERS, County Wicklow, Ireland, and the remaining TWENTY-FIVE PERCENT (25%) to be given to the ABBOT OF KILNACROT, Ballyjamesduff, Co. Cavan, Ireland, toward the building of the new Monastery.

SEVENTH: I intentionally and with full knowledge omit to provide for any of my heirs or relatives or for any person or persons claiming to be such, whether now living or hereafter born, except as provided in this Will.

EIGHTH: If at the time of my death I own my residence at 12206 B. Rancho Bernardo Road, Rancho Bernardo, California, then I direct that such residence shall be sold. I further direct that MONSIGNOR DANIEL COLLINS, St. Lawrence Martyr Church, 1900 Prospect Street, Redondo Beach, California 90277, be given the first choice to purchase said residence before said property is offered for sale to the open market.

NINTH: I appoint Reverend THOMAS F. BYRNE as Executor to serve without bond. If for any reason he is unable, unwilling or fails to serve as said Executor, then I appoint Reverend MICHAEL J. COUGHLAN as Executor to serve without bond. I direct

that all death taxes of every kind which may be due by reason of my death be paid from the residue of my estate without apportionment, deduction or reimbursement therefor. I authorize my personal representative to sell property of my estate subject to court confirmation as may be required by law. I request my personal representative to retain my attorney, VINCENT J. McMAHON.
