Reverend David H. Roll, Jr. 27, the son of Mr. and Mrs. David H. Roll, 1411 Thomas Avenue, San Diego, will be the first University High School graduate to become a Catholic priest when he and Reverend Robert E. 

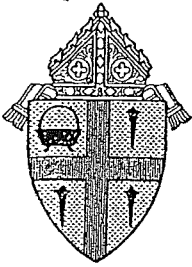



1. An articulate, if aspecific, accusation of sexual misconduct against Rev. Roll was made in 1976. No evidence of any action taken was found in his file.
2. In 1986, Bp. Maher received accusation by police regarding alleged sexual misconduct by Roll. Bp. Maher put Roll "on probation" and withdrew faculties. There is no such thing as "on probation" in canon law. Doubtless, "withdrawing faculties" meant to Bp. Maher that Roll was suspended. Such an action--as opposed to acting under c. 1722, for example--would have been illegal under the new Code.
3. By 1987, however, there was overwhelming professional evidence of Roll's complete inability for ministry (coprolalia, suicidal ideation, etc). This evidence was basically repeated up to at least 1993/94, when Bp. Brom placed Roll on permanent disability retired status. This concept solves certain financial questions, but does not clearly address Roll's canonical status.
4. The easiest thing to do, I suggest, is impeded-for-exercise:  

"Having reviewed the extensive psychological reports on Rev. David Roll, and understanding Bp. Maher to have prohibited Rev. Roll from all ministry in 1986, I hereby confirm that Rev. Roll is now, and always has been considered by me to have been, prohibited from the exercise of all ordained ministry in accord with 1983 CIC 1044, n. 2." Signed bishop, co-signed chancellor, etc.
5. As for as Kenedy listing: they have no category for "impeded". Maybe created one (not recommended) or could call them something like "disability retired, without faculties" or just plain "without faculties", "not currently authorized for ministry". Something that would tell the faithful--and a jury--that X is not being held out by us as able to engage in ministry.

Several weeks ago you received a letter of introduction from Dr. Sarah Brennan, the recently appointed clinical director of the Albuquerque Villa. This is the follow-up letter with a brochure and fact sheet which you had been promised.

Since the early 1950's the Villa has been at the service of priests and brothers with a wide variety of psycho-spiritual and emotional needs. Throughout the years the Servants of the Paraclete and their professional staff sought to adapt themselves to the changing needs of priests and brothers in their ministry.

It is not surprising that the rapid and significant changes and events of recent years have had an impact on the quality of life and ministry of priests and brothers. Stress, anxiety, frustration, and not a little anger and confusion are common experiences for many of today's ministers struggling to meet the ever changing demands on their time, energy and resources. Destructive and inappropriate behavior are often symptomatic of these underlying unresolved conflicts.

A common experience of the Servants and our professional staff today is that of seeing many gifted, dedicated and zealous priests and religious suffering the consequences of this inappropriate and self-destructive behavior. Together we have designed and implemented a **new and innovative program** of therapy building on the past, but designed to address the emerging needs of today's ministers

Because we are relatively small (19 bed capacity), with a small resident staff ratio, we are in a unique position to offer a personally designed program concentrating on the particular needs of each resident.

The Servants of the Paraclete, together with their professional staff, have learned much over the past several years. We have sought to serve the needs of the Church in her ministers and have found ourselves often treading where others had not yet ventured. We have born the burden of our mistakes and have grown in the process. It is not an exaggeration, I hope, to suggest that many programs operative today have built on our experience. Today at the Albuquerque Villa we are a unique community of professionals, lay and religious, men and women, who are drawing from our shared experience to offer you a program that is a rare combination of traditional spiritual values and sound compatible psychological insights. We look forward to serving you.

# THE ALBUQUERQUE VILLA

## FACT SHEET

**The Facility:** 19 beds; Swimming pool; tennis court; walking track; New Mexican style chapel and dining room. Located in a rural section of metropolitan Albuquerque, NM; 20 minutes from International Airport.

**Eligibility:** Priests and brothers who will benefit from a therapeutic community environment.

**Treatment focus:** Psycho-sexual misconduct allegations from the past; other psycho-sexual problems such as celibacy/lifestyle; sexual misconduct. Psycho-spiritual; emotional, vocational transition.

**Cost:** \$80.00 per day basic cost for room and board; includes light housekeeping and laundry facilities; three meals a day and snacks. Weekly classes in scripture, spirituality and prayer; recreational and health program; weekly sessions with the spiritual director; pottery class. Does not include personal expenses for recreational or cultural activities; van transportation to and from town; counseling, psychological or psychiatric services; medical treatment.

**Staff:** Rev. Raymond J. Gunzel, SP, director and administrator; Sarah Brennan, PhD, clinical director, individual psychological therapy, group therapy and evaluations; Robert Goodkind, PhD, group therapist and consulting psychologist; Jay Feierman, MD, consulting psychiatrist. Francis Dorff, O.Praem., STD, spiritual director and instructor in spirituality.

**Communications:** Communications with ongoing support from sponsoring diocese/religious community. Phone calls, including conference calls, FAX, progress reports, and visits are encouraged.

**Staff-client-sponsor visits:** The staff, at an appropriate time during treatment, will schedule a visit by the Bishop/superior (or a representative).

**Discharge:** Each client goes through an individualized course of treatment. Periodic reviews and evaluation, in conjunction with the bishop/superior and the resident are held in order to evaluate the progress of treatment.

**After-care and follow-up:** Frequent and regular contact is kept open for the first months after a person returns to ministry. This is done through phone calls, letters and an on site visit. An after-care program may include 12-Step programs, weekly visits with a psychologist and/or spiritual director, as well as other support groups.

**Return visit:** The staff will arrange periodic return visits for the purpose of monitoring and reinforcing the ongoing recovery and continuing care.

**Evaluations:** The Albuquerque Villa has in place a program of psychological and spiritual evaluations to help bishops and superiors avail themselves of the best possible treatment for the men under their jurisdiction.

**Outreach:** The staff of the Albuquerque Villa is available for on site consultations and personnel training workshops with religious communities and dioceses.

This movement has been initiated out of concern for responsible stewardship which now directs our need to modify the role the Diocese of San Diego will assume in your treatment. We have been communicating with Dr. DeBlasio regarding this matter and encourage you to discuss with him your decisions.

Based on the time involved in your treatment and the information submitted for professional review, the following has been established:

- 1) All billing arrangements will be arranged directly by you with your provider. Any Diocesan subsidy will be paid out or reimbursed to you directly. Current Diocesan subsidy for individual sessions have been set at a payable limit of \$85.00 per session. Charges exceeding this limit will not be reimbursed and will be your responsibility.
- 2) Arrange to reduce sessions to once weekly within one month of receipt of this letter.
- 3) Arrange referral for an evaluation of potential benefits of medication. Your condition as identified has often been greatly assisted by the responsible use of select medications.
- 4) Explore and identify the availability of a suitable Day Treatment Program that may assist with socialization skills and self-care management. Identify facilitated skill development training program.
- 5) Active referral and required attendance at self-help group.
- 6) It is recommended that weekly sessions be extended for a period of up to six months with a possibility of continuing medication supervision.

The change in arrangements reflect both responsible stewardship and our wish to increase your assumption of responsibility for a realistic personal care plan at this point. We have asked Dr. DeBlasio for his professional support in assisting you in completing this transition. We hope to receive notification on a timely referral for a medication evaluation, the possibilities of a group day treatment program, and, referrals to self-help programs.

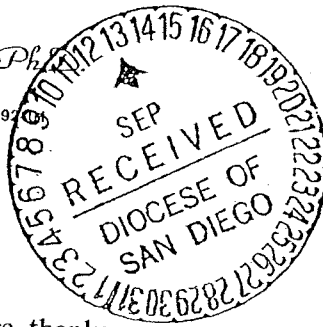


