

Rev. Andrew A. Ulincy, died on Friday, 28 October 2016, at the age of 80. A native of Bethlehem, Father Ulincy was the son of the late Andrew J. and Appolonia (Palenchar) Ulincy. Father Andrew will be greatly missed by his family, parishioners, and friends. Survivors: He is survived by a sister, Margaret Maher, Potomac, Maryland; many nieces and nephews and great-nieces and great-nephews.
